Who is in favor of a casino in Muskegon County?

(This article includes a letter I wrote in response to news reports I read in the *Muskegon Chronicle*. It is submitted so those who do not read the *Chronicle* can know my views on a controversial subject. I am aware of the fact that many in the Fruitport area will not appreciate my point of view. There are people throughout the entire county who question the propriety of legalized gambling. Even people in Fruitport Township would no doubt agree that a county-wide vote for approval of a casino was never put on the ballot.)

The *Chronicle* headline on July 4 should have read, "Fruitport casino plan again wins county commissioner support, not county support." Is Marcia Hovey-Wright more accurate or honest when she represents her district on other matters than when she spoke about her disappointment that Governor Snyder didn't give the okay for the casino in Muskegon County? She said that the people want it. How does she know?

There was never a county-wide vote by the people. It seems that politicians wanting the casino refused to call for a county-wide vote lest it not turn out to their advantage. Instead, politicians like Marcia Hovey-Wright continue to glory in the approval by voters in the City of Muskegon. Remember that a "yes" vote was promoted as the answer to unemployment. Also remember at that time the casino under consideration was proposed for downtown Muskegon. City residents were told about the large sums of money projected for the city's coffers.

Likewise, Fruitport's affirmative vote is promoted as approval of the casino by the people of Muskegon County. Fruitport would be the recipient of funds since the casino would be within their borders. People of other municipalities know that casino costs would be shared by everyone in the county. Tax dollars would be used for courts, welfare, etc.

Please take this thought into consideration: Most of the gamblers will come from a fifty-mile radius. A casino in a resort location draws tourists. A populated area such as greater Muskegon would draw gamblers from neighborhoods that cannot afford to support the gambling industry. The number of people employed by the tribes would be insignificant compared to the number of people and businesses that would be seriously hurt by the casino.

It was disappointing to see that Senator Geoff Hansen will use his office and influence for the promotion of the casino for Muskegon County. Is he unable to see that it is morally wrong to take advantage of another's weaknesses for material gain?

Governor Snyder, as a business man, encouraged and motivated others to contribute effort and ingenuity for the success of his firm and as a contributor to society. He sought also to encourage tribal leaders to diversify and use their capital for other business endeavors rather than have their people rely only on gambling for their livelihood. This makes sense. If one's children could live off the interest of family wealth it would be a bad idea. How much better if the children were ambitious and creatively made it on their own, thereby accomplishing something of worth. The same would apply for the well being of Native Americans. How much better than to skim and scam those who want to strike it rich at the casino but won't.

The governor did the right thing and should be commended. Hopefully, Marcia Hovey-Wright, Geoff Hansen and other politicians will not continue to try to alter the facts in the promotion of a casino because there never was a county-wide vote for or against the casino. •
