

**Dear Michigan Reader,**

I was once one of those moms who strongly believed in vaccines. I was the mom who made sure everyone around my children were vaccinated to "keep my children safe". I even threatened grandma and grandpa that they wouldn't be visiting their new grandchild until they got their flu and TDaP (whooping cough) shots. I look back on those early days and wish someone had told me the truth before our lives would be turned upside down.

My children are vaccine injured. Our journey into vaccine reactions really started with our son but at the time, I didn't know it. It was when my daughter came along 5 years later that our understanding of what had really happened to her brother became blindingly apparent. But I will start with my daughter's journey with vaccines;

When our baby girl was 2 months of age, she developed infantile spasms, which is a potentially brain-damaging seizure disorder, directly following her vaccinations. We were shocked as we were never told that this could happen and thought that the only risks were soreness at the injection site and perhaps a fever. After that, we were reluctant to give her anymore vaccines but when she turned 4 years old, her pediatrician finally persuaded us to "start catching her up on her vaccines so she could attend school". He also threatened to discontinue care to our family if we did not comply. (I later discovered that Michigan allows children vaccine waivers to still attend school and that with her history of adverse reactions, she should never have been given any more.) Well, three days after her "catch up vaccines" she developed severe facial tics every 1-2 seconds. She also developed a strange circular rash on her torso that no specialist recognized and all treatments failed. After 2 years of persistent rashes she developed more rashes when exposed to the sun which finally alerted doctors that she might have an autoimmune disease. We finally discovered that the rashes that started after her 4 year shots were the first symptoms of Lupus.

My daughter developed seizures, facial tics, and LUPUS from vaccines. Her life is now in serious danger and she has to be on life-long medications and followed by Rheumatology, Nephrology, Neurology, ophthalmology, and Dermatology for life. She can't go in the sun, she is subjected to multiple invasive medical procedures and evaluations, she has chronic headaches, and now has to take medications that can cause blindness. She is only 7 years old.

So back to her brother. He has had a turbulent childhood. Since toddlerhood he struggled with repeatedly severe high fevers, sometimes paired with hallucinations. He then developed night terrors, then an anxiety disorder and a sensory integration disorder, and then at two years of age he regressed into autism. He no longer responded to his name, would repeat "diggity diggity diggity...." over and over and stopped playing with toys appropriately, and would have complete panic attacks while changes in routines.

All of his doctors told me it was not the vaccines. As a speech pathologist and autism specialist, I can safely say that he was not born with autism as many might argue. I had also been trained that "autism isn't caused by vaccines". I was told "the science is settled". So I never wanted to question the doctors when our children regressed.

After his sister's vaccine injury happened, I began to read the medical journals on vaccines for myself. I began to research the CDC, HHS, and NIH on how vaccines are manufactured, how they are tested, and how these regulatory agencies ensure safety, and to my astonishment, I discovered that they are failing miserably. I found out that vaccine manufacturers have not even been liable for injuries since 1987 and that their safety science was shady and fraudulent. I also discovered that not a single vaccine on the US Childhood Vaccine Schedule has ever been tested against an inert placebo in a double blind study (unlike drugs that are regulated by the FDA), and that the CDC has approved 72+ vaccines without proper safety oversight.

So after much inner conflict, I finally forced myself to pull his medical record and cross reference it with his vaccine record. With tears of dismay, I discovered direct correlations to his fevers, his behavioral changes, and regression to

when he received vaccinations. At that moment, my heart broke into a million pieces. As a mother, I was supposed to be his protector and his advocate, yet I came to discover that every time I obediently brought my son to his doctor's "well visits" to get his vaccines, I was allowing them to unwittingly poison and neurologically damage my son. - A moment no mother should ever have to endure.

I look back on my son's life and how he saw countless specialists and therapists and realized that none of them actually treated my son for the condition he was actually suffering from. A MEDICAL CONDITION- neurotoxicity and encephalopathy from toxins in the vaccines.

The lies of the CDC, HHS, NIH that vaccines cannot cause autism has been one of the most egregious and damaging lies this government has ever done to it's citizens. Children are suffering while not being recognized for the actual medical condition they have, and thus not being treated properly. Entire lives and their families have been destroyed because of this lie!

We want our government to acknowledge that vaccines are not a one-size-fits-all and that they can cause life-long disabilities. Americans must require ALL public safety and regulatory agencies not receive \$\$ from BIG corporations that would create conflicts of interest. We should make vaccine manufacturers liable again, make doctors take classes on vaccine injury, and require them to ALWAYS report to VAERS up to 1 year post vaccination.

Most importantly, I want all parents to know what the possible dangers to vaccines are. I want to share our stories so as to hopefully save a child from the fate my children endure. These injuries are not "1 in a million" like doctors claim. 54% of American children now have a chronic disease and we have the highest infant fatality rate on the first day of life than all western countries put together, and yet we are the most vaccinated starting with vaccination on the 1st day of life.

I wish someone had told me.

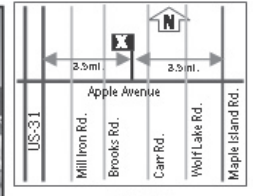
